Centro Unido offers a variety of services focused on areas of health, workforce development, education, leadership, advocacy, and more. Centro Unido provided an average of 2,500 services a month during the fiscal year through our 10 different programs.

Through our Food Pantry program, we address food insecurity, and we provide access to fresh produce and nutritious foods. We served a total of 4,408 families in McDowell County and surrounding areas and distributed more than 130,000 pounds of food.

Our Healthy Minds program is one of our most successful programs that address mental health stigma and access to culturally responsive mental health resources. This program impacted more than 1,500 individuals during this fiscal year and 102 individuals were able to access therapy at no cost, with a total of 995 therapy sessions.
